## **Directions For Use-For General Turf Use**

Golf Course Greens, Tees, Fairways, Lawns & Sports Turf

**Injection Application:** Inject 12 to 24 fluid ounces (360 ml to 720 ml) per acre (0.5 hectare) on a monthly basis.

**Injection Application For More Difficult Areas:** Inject 48 fluid ounces (1,440 ml) per acre (0.5 hectare). **HYDRO-WET INJECTABLE** can be applied through all injection systems.

**Ground Spray Equipment:** Apply 1 to 2 fluid ounces (30 ml to 60 ml) per 2 gallons (8 litres) of water per 1,000 square feet (100 square metres).

#### Tank Mixing

Tank mix combinations containing **HYDRO-WET INJECTABLE** have not been tested under all growing conditions. Applicator should follow instructions of pesticide label to determine such use. Always exercise caution when using wetting agents with other commonly used turf chemicals and fertilizers. Test a limited turf area prior to large scale applications.

#### Storage and Disposal
